# 1. Call Meeting to Order

Chairperson Lew Penney called the meeting to Order at 7 pm.

# 2. Traditional Territory Acknowledgement

Chairperson Penney recognized that the meeting is occurring on the traditional territory of the Coast Salish people.

# 3. Approval of Agenda

Moved/Seconded by Trustee Slade and Ratepayer Olive to approve the agenda as circulated.

# 5. Presentation of the 2021 Financial Statements

Ms Blomer of MNP presented a snapshot the 2021 Financial Statements including the Statement of Financial Position, the Change in Net Financial Assets, Cash Flow, Portfolio Investments, the Schedule of Reserves and the Notes, specifically Note 1 regarding the 2020 restatement.

# 6. Chairperson Report 2021

- Chairperson Penney welcomed ratepayers and guests and thanked everyone for attending and then introduced the Trustees and Staff.
- Chairperson Penney noted that the Annual General Meeting was advertised in the local newspaper, posted on the website, in the newsletter and that an Alert was sent out to ratepayers.
- Chairperson Penney presented the Annual Report and noted that the pandemic did create challenges in 2021 and that many of the regular meetings were by Zoom or under social distancing procedures.
- Chairperson Penney noted that the Water Improvement District has high water quality, which requires minimal treatment. The water is tested on a regular basis to ensure that it is safe for consumption.
- 2021 was a year of staff change and completion of the draft Master Plan. The Master Plan is a guide for renewal and how to utilize resources and plan for the future.
- There were three water main breaks in 2021 and upgrades were completed on the electronic monitoring system
- Chairperson Penney noted a significant accomplishment was adoption of a Complaints Policy to ensure fair and equal treatment; both for the complainant and for ratepayers.

# Looking Ahead - 2022

- Chairperson Penny advised that the Booster Pump Station and the Ordano Road Complex is complete and meeting fire protection standards for Pressure Zone 2 residents.
- The Office staff will continue updating procedures and policies in order to provide better service to ratepayers. A key part of this work is implementing a filing system.
- Additionally, implementation of the recommendations in the Master Plan will be a top priority.
- Staff are working on a partnership for the replacement of the watermain from the Hotel to Hecate Park. The goal is to replace the water line at the same time the new sewer line is installed in order to reduce the impact upon the traffic in the Village.
- A Source Water Protection Plan is underway to assess and plan for risk at the four well sites.

#### 7. Draft Master Plan

Chairperson Penney advised of the recently completed Draft of the Master Plan. It was requested that the document be updated to include the 2021 Census data.

#### 8. Question Period

- A question was asked about noise and water pressure in relation to the new Booster Station at the Ordano Complex. The purpose of the Booster Station is to regulate water pressure in the event of a fire, and as always, the Water Improvement District recommends that all residents ensure they have installed a pressure reducing valve in their home.
- The Booster Station is meant for emergencies and except for the weekly test, should not make noise, except in the event of an emergency.
- A question was asked why the Parcel Tax has increased. Chairperson Penny noted that costs are
  escalating, impacting the cost of supplying water. Additionally, the Master Plan has identified
  and prioritized upgrades to the aging infrastructure. The parcel tax fund is utilized to complete
  this required capital work.

Director lannidinardo advised that the CVRD is in the same situation as Cowichan Bay Waterworks and when budgets are kept low, taxes eventually have to go up in order to keep up with infrastructure replacement programs.

A ratepayer suggested that this could perhaps be better communicated.

# 9. Election of Trustees

- The District Administrator advised that there were two Trustee positions open and that two nomination forms had been received to date.
- Chairperson Penny called for nominations.
- Hearing none, Chairperson Penney called for nominations a second time.
- Hearing none, Chairperson Penney called for nominations a third time.
- Hearing none, Chairperson Penney declared Trustee Slade and Trustee Gregg, re-elected by acclamation for a three year term.

# 10. Trustee Remuneration Policy

As per the Letters Patent for the Improvement District, the Trustee Remuneration Policy is to be reviewed annually.

# 11. New Business - CVRD Update

- Director lannidinardo updated the ratepayers on the proposed 3 Stream Waste System [garbage, recycling and organics] as organics currently comprise 40% of the garbage volume.
- The Official Community Plan Harmonization is ongoing, modernizing policies and providing for more efficiency across the regional district.
- The Cowichan Bay Business Association and the Community Police Building in the Village along Cowichan Bay Road are not active and volunteers are needed.

# PROVINCE OF BRITISH COLUMBIA.

GEORGE THE SIXTH, by the Grace of God, of Great Britain, Ireland, and the British Dominions beyond the Seas, KING, Defender of the Faith, Emperor of India.

To all to whom these presents shall come—GREETING.

JOHN HART,
Acting Minister of Lands and Forests. WHEREAS by section 49 of the "Water Act, 1939," it is provided that the Lieutenant-Governor in Council may incorporate a tract of land and the owners

thereof into an improvement district:

And whereas the Licutenant-Governor in Council has by Order in Council made pursuant to the said Act been pleased to order that the tract of land hereinafter described and the owners thereof be incorporated into an improvement district under the said Act and has made further provision to the tenor and effect hereinafter appearing:

Now know ye that by these presents We do

hereby order and proclaim:---

1. The tract of land comprising Lots 1 and 2, Block U, and Lots 6 to 14 (inclusive), Block T, Registered Plan 79, as amended, and District Lots (foreshore) 162, 171, 173, and 189 to 217 (inclusive), Cowichan District and Victoria Land Registration District and all subdivisions thereof, and the owners of land in the said tract are incorporated into an improvement district under the "Water Act, 1939," and subject to the provisions thereof and to the conditions hereinafter contained.

2. The said improvement district shall be known as the "Cowlchan Bay Waterworks

District."

3. The objects of the said improvement district shall be the acquisition, maintenance, and operation of works for waterworks purpose and the provision of fire-protection and all matters incidental thereto.

4. There shall be five Trustees of the said

improvement district.

of The persons qualified to vote at the first election of Trustees shall be British subjects who are twenty-one years of age or older and are not disqualified from voting in an election under the "Provincial Elections Act." and are owners of land in the tract of land hereinbefore described, and the persons qualified to be candidates at the said election shall be the persons qualified as aforesaid to vote and their wives and husbands.

6. Arthur Hardy, of Cowichan Bay, B.C., shall be Returning Officer for the first election

of Trustees. He shall call a general meeting of the persons who are qualified as aforesaid to vote and shall, at least seven days before the date of the said meeting, post in a conspicuous place at the post-office at Cowichan Bay, B.C., a notice signed by him giving the date, time, and place of holding the said meeting. The Returning Officer shall be chairman of the said meeting and he shall have power to determine whether or not any person who desires to vote is qualified to do so. He shall have power to determine the procedure to be followed at the said meeting and the method of taking the votes. Each qualified voter shall be entitled to cast one vote for each of five candidates. The Returning Officer shall declare the result of the election and shall advise the Comptroller of

Water Rights of the said result.

7. The candidates elected as Trustees for whom the greatest and second greatest numbers of votes are cast at the general meeting called pursuant to clause 6 hereof shall hold office until the annual general meeting of 1949. the candidates elected for whom the third and fourth greatest numbers of votes are cast shall hold office until the annual general meeting of 1948, and the candidate elected for whom the fifth greatest number of votes are cast shall hold office until the annual general meeting of 1947, but should there be nominated no more than five candidates for the office of Trustee, or should any two or more candidates receive an equal number of votes, then the Returning Officer shall have power to and shall declare which of the candidates elected shall hold office until the next, the second, and the third succeeding annual general meetings respectively.

8. All subsequent elections of Trustees shall be held at the annual general meetings of the improvement district and it shall be the duty of the Trustees to call a general meeting to be held between January 1st and May 1st in each

year for the following purposes:-

(a.) To receive from the Trustees a report on condition of the works and a statement of the financial condition of the improvement district:

(b.) To discuss with the Trustees any matter relating to the works or finances of

the improvement district:

(c.) To fix the remuneration of the Trustees

for the ensuing year:

- (d.) To elect a Trustee or Trustees to succeed those whose terms of office expire coincident with the holding of such annual general meeting, and to elect a Trustee of Trustees to fill any other vacancy or vacancies that has or have occurred or is or are about to occur among the Trustees:
- (e.) To choose the auditor for the ensuing year.

[OVER.]

A special general meeting may be called by the Trustees at any time for the purpose of electing a Trustee or Trustees to fill any vacancy or vacancies among the Trustees, or for the purpose of discussing with the owners any matter or matters which in the opinion of the Trustees should be brought up at a general meeting.

At least seven days' notice of every general meeting shall be given by a notice posted up in a conspicuous place at the post-office at Cow-

ichan Bay, B.C.

The secretary shall enter in a book provided by the Trustees for this purpose minutes of all matters brought before the meeting and the action taken thereon. At any general meeting every person shall be qualified to vote who is a British subject and is twenty-one years old or older and is an owner of land in the improvement district, or the authorized agent of any board or corporation that is an owner of such land, or the legal representative of any owner or such land who has died, become insolvent, or insane, and is not disqualified from voting in an election held under the "Provincial Elections Act." Every person qualified as afore-said to vote and the wife or husband of any such person shall be qualified to be a candidate for and to hold the office of Trustee, but no person shall be entitled to vote or be a candidate for Trustee or hold the office of Trustee while there is owing to the improvement district in respect of the land held by him or her or by his wife or her husband any taxes, tolls, or other charges other than those levied, fixed, or charged by the Trustees within one year of

the date of the meeting. In the event of the right of any person to vote at any general meeting being challenged, the chairman shall have authority to determine whether or not such person is entitled to vote, and the chairman may require such person to make and file with him a statutory declaration showing that the declarant is qualified as aforesaid to vote at such general meeting. Forthwith after the holding of a general meeting the Trustees shall file with the Comptroller of Water Rights a true copy of the minutes of such meeting and copies of all auditors' reports and financial statements presented or discussed at the meeting.

7. All words and phrases given special meaning in section 2 of the "Water Act, 1939," shall, where used herein, be ascribed the meaning given them in the said section unless the

context otherwise requires.

#### **PURPOSE**

To establish a Cowichan Bay Waterworks District Trustee Remuneration Policy.

#### DISCUSSION

The Cowichan Bay Water District delivers clean, safe, potable water to a rapidly growing village through about 754 residential and commercial connections, making it one of the larger Water Districts on Vancouver Island. Trustees are responsible for the governance and management of the Water District and bring their various skills, professional experience, and post-secondary educations to this community service role. Trustees are remunerated with an honorarium in recognition of this contribution and the time and effort involved. As per the Order in Council creating the Cowichan Bay Waterworks District on the 12<sup>th</sup> day of August, 1946, the Trustee remuneration must be fixed for the ensuing year.

#### **POLICY**

- 1. Trustees shall be remunerated with a monthly honorarium of \$200.
- 2. The Chair shall receive an additional fifty percent (50%) of the amount paid to Trustees.
- 3. The honorarium is paid based on a calendar month and is
- 4. The honorarium is pro-rated in situations where the Trustee joins or leaves the Board part way through the month.
- 5. The honorarium is paid quarterly and is taxable income.
- 6. The honorarium does not cover approved expenses of Trustees while on CBWD business. Those expenses are reimbursed in accordance with current reimbursement policies.
- 7. The honorarium shall not be paid to a Trustee who is not available to participate as a Trustee for a period of more than two weeks. (I.e. on vacation without digital access or unable to participate due to illness or disability.)
- 8. The honorarium shall be pro-rated to reflect the time the Trustee was unavailable beyond the first two weeks.
- 9. All remuneration to Trustees will be published on the district's website quarterly.
